What is the Performance Based Contract?

On Jan. 1, 1993, Senate Bill 1383 amended the Lanterman Act requiring a five-year performance contract between each regional center and the Department of Developmental Services (DDS). NLACRC successfully completed its last five-year contract in 2004.

In 2002 DDS created a new performance contract that establishes a comprehensive performance-based accountability system for regional centers. The contract includes goals such as less consumers living in developmental centers, more children and adults living with families or in home settings, and less children and adults living in large facilities.

This contract also includes a section for local outcomes, or those developed with input from consumers, families and others. The public meetings are your opportunity to suggest local outcomes that you would like to see added to the 2011 performance contract.

How can you participate?

2. Think about local outcomes – are there any measurable areas you would like to see included in NLACRC’s 2011 performance contract?
