To: **NLACRC Service Providers with Negotiated Rates**

Subject: **Rate Changes due to Minimum Wage Increase effective January 1, 2016**

Due to the enactment of Assembly Bill 10 (AB 10), the California minimum wage will increase from \$9.00 per hour to \$10.00 per hour effective January 1, 2016. The proposed budget trailer bill, combined with current Title 17 regulations, will allow for both the Department of Developmental Services (“DDS”) and North Los Angeles County Regional Center (“NLACRC”) to increase rates as a result of the minimum wage increase for eligible service providers. This letter contains information on the service providers affected by the proposed budget trailer bill and the process for submitting rate adjustment requests to **NLACRC** for eligible service providers.
