**To: Non-Mobile Supplemental Staffing Rate Increase  
Community Based Day Programs under Service Codes 505, 510, 515**

**RE: Adjustment for Minimum Wage Increase effective January 1, 2019 pursuant to WIC,  
Section 4691.6(g)**

Due to the enactment of Senate Bill 3 (“SB3”), effective January 1, 2019, the minimum wage in the State of California will increase from \$11.00 per hour to \$12.00 per hour for employers with 26 or more employees and from \$10.50 to \$11.00 per hour for employers with 25 or fewer employees. As authorized by the current State budget and Welfare & Institutions Code (“WIC”), Section 4691.6(g), effective January 1, 2019 the non-mobile supplemental staffing rate will increase from \$1.40 per consumer per hour to \$1.44 per consumer per hour. Therefore, effective January 1, 2019, the new non-mobile supplemental rate for Community-Based Day Programs serving non-mobile consumers has increased from \$8.40 per consumer per day (\$1.40 per consumer per hour x 6 hours) to \$8.64 per consumer per day (\$1.44 per consumer per hour x 6 hours).

The new non-mobile supplemental staff rates will be reflected on your January 2019 invoices that will be available in eBilling during the latter part of January 2019. If you have any questions regarding this information, please contact your account payable representative, as follows:
