#### I. Call to Order & Introductions

Caroline Mitchell, chair, called the meeting to order at 6:05 p.m. and introductions were made.

II. Public Input – There was no public input.

#### IV. Committee Business

# A. 2<sup>nd</sup> Quarter Exceptions/Exemptions Report

The <u>exceptions</u> report lists requests from consumers and families for services that are outside of the center's service standards and whether those services were approved or denied. During the 2<sup>nd</sup> quarter of this fiscal year, the center approved 276 requests, approved an alternate service for 1, and denied 1.

The <u>exemptions</u> report lists requests made for services that have been suspended or reduced as a result of the trailer bill language for respite. The report showed that during the 2<sup>nd</sup> quarter, the center approved 2 requests, approved an alternative service for 2, and denied 0.

# B. 2<sup>nd</sup> Quarter Appeals/Hearings Report

Copies of the report were included in the meeting packet. During the 2<sup>nd</sup> quarter:

- 1. <u>Eligibility</u>: 573 Notices of Action (NOAs) were sent and 15 were returned (appealed); 6 additional hearings were requested from NOAs sent in previous quarters.
- 2. <u>Service</u>: 287 Notices of Action were sent and 5 were returned; 5 additional hearings were requested from NOAs sent in previous quarters.
- 3. <u>Hearings</u>: 3 fair hearings were held:
  - 2 eligibility hearings (1 denied and 1 dismissed)
  - 1 service hearing (dismissed)

## C. <u>2<sup>nd</sup> Quarter Consumer Diagnosis Report</u>

Copies of the report were provided to the committee for their review, which showed diagnostic information about the center's consumers each quarter since FY 2017-18. Of the 27,176 consumers that the center serves, the diagnosis breakdown is as follows:

- 1. Intellectual Disability: 8,914
- 2. Autism: 11,910 (an increase of 20.93% since July 1, 2017)
- 3. Cerebral Palsy: 563
- 4. Epilepsy: 251
- 5. Other developmental disability: 1,256
- 6. Status 0, 1, 2: 4,279

Status 0 are clients in intake, Status 1 are clients in Early Start (at risk), and Status 2 clients are children over 3 that have been found eligible for regional center services.

# D. <u>Monthly Community Resource Development Plan (CRDP) and Community Placement Plan (CPP) Report</u>

We are still trying to place our final consumer living at Fairview Developmental Center as the community placements attempted did not work out. The plan is to move this consumer into Canyon Springs or Desert Star until we finalized the development of our enhanced behavioral support home (EBSH) in about 2 years. We are also in the process of finding community placements for 5 consumers at Porterville Developmental Center and 2 consumers at Canyon Springs.

## E. <u>Self-Determination Program (SDP) Update</u> (Sheila)

On November 22<sup>nd</sup>, the Department of Developmental Services (DDS) conducted a second selection of applicants to replace those who had withdrawn from the program. Unfortunately, due to an error, we did not submit all of the names on the interest list to DDS; we are in the process of rectifying that situation. NLACRC received 46 new applicants (8 AV; 9 SCV; 29 SFV). Orientations for interested applicants continue to be held monthly at 1 of the center's 3 offices. New staff trainings are being held. We have also surveyed our staff to help identify any barriers they have faced during the process. We now have 2 SDP specialists, on in the San Fernando and the other in the Antelope Valley. The Self-Determination Advisory Committee continues to meet monthly at 1 of the center's 3 offices; generally on the 3<sup>rd</sup> Thursday of the month at 7:00 p.m. The next one will be held February 20<sup>th</sup> at the AV office. The SDP should be open to all consumers sometime in 2021.

**Action:** Sheila will share the staff survey results at next month's committee meeting.

## F. <u>Person-Centered Planning Information</u> (Jesse)

Person-centered planning is the heart of the work we do. We will be updating our staff trainings on person-centered planning using subject matter experts to make our trainings more effective. Tri-Counties Regional Center gave us a SDP workbook that includes a section on person-centered planning that we plan to use.

**Action:** Jesse will share copies of Tri-Counties SDP workbook at next month's committee meeting.

Marianne suggested using visuals when preparing person-centered planning materials for consumers.

# V. Chief of Program Services Report (Jesse Weller)

## A. Assessment Tools

Trailer bill language required all regional center to post any and all tools they use for assessment purposed on their websites. NLACRC has posted all of its assessment tools and is in compliance.

#### B. <u>Service Videos</u>

Our Family Empowerment Team in Action (FETA) is a program that uses MSW students from CSUN to provide outreach to families who are not using regional center services. They are currently helping us film videos on a variety of subjects, including the importance of IPP meetings and how to prepare for them, and school age, transition, and adult services. The videos will be available in both English and Spanish. Jesse expressed his appreciation to the following board members for agreeing to be filmed for the videos: Adam Breall; Marianne Davis (and daughter WuDi); Elena Burnett (and son Ricky Jr.); and Lillian Martinez.

### C. <u>Cafecitos</u>

Starting next month, Cafecito Entre Nos meetings with Spanish-speaking families will rotate and the monthly meetings will be held at San Fernando Valley and Antelope Valley. These meetings are very well attended with guests coming from other regional centers' catchment areas. The attendees have also expressed an interest in having trainings, so a new event was formed called Aprendiendo Entre Nos (learning amongst us). In addition, NLACRC will be launching Grupo de Hombres (men's group).
