## 1. Introduced Bills

Belinda Abatesi provided 8 major updates to the committee.

\*CHAPTERED after a bill has been signed by the Governor, the Secretary of State assigns the bill a Chapter Number.

- **AB 277 (Alanis) Autism: Behavioral Technician Certification**

Status: January 21, 2025, the bill was introduced, and re-referred to the Committee of Human Services on February 21, 2025.

- **AB 308 (Ramos) The Family Urgent Response System - (Gipson) Persons with disabilities: terminology -**

Status: On January 23, 2025, the bill was introduced. On March 4, 2025, it was re-referred to the Committee on Human Services.

- **AB 341 (Arambula) Oral Health for People with Disabilities Technical Assistance Center Program-**

Status: On January 28, 2025, the bill was introduced. On February 18, 2025 it was referred to the Committee on Human Services and Higher Education.

- **AB 416 (Krell) Involuntary Commitment -**

Status: On February 5, 2025, the bill was introduced. On February 18, 2025 it was referred to the Committees on Health and Judiciary.

- **AB 1172 (Nguyen) Adult Day Programs: Administration of Inhalable Emergency Antiseizure Medications-**

Status: On February 21, 2025, the bill was introduced and pending legislative review.

- **SB 402 (Valladares) Health Care Coverage: Autism-**

Status: On February 14, 2025, the bill was introduced. On February 26, 2025, it was referred to the Committee on Business, Professions & Economic Development.

- **SB422 (Grayson) California Workforce Development Board: developmental services-**

Status: On February 18, 2025, the bill was introduced. On February 26, 2025, it was referred to the Committee on Labor, Public Employment & Retirement, and Human Services.

- **SB471 (Menjivar) Office of Lanterman Ombudsperson-**

Status: On February 19, 2025, the bill was introduced. On February 26, 2025, it was referred to the Committee on Human Services and Judiciary.

E. ARCA Grassroots Sacramento Visit

Belinda Abatesi shared on the ARCA Grassroots Sacramento Visit on March 3<sup>rd</sup> and 4<sup>th</sup>. During the visit, the group met with legislators and their staff within NLACRC's local catchment area. Belinda Abatesi shared positive feedback on the meetings, where ARCA's proposed bills were discussed and advocated. These discussions aimed to secure legislative support for policies and to strengthen the individuals and families served and the overall regional center system. The ARCA Grassroots Sacramento Visit was a way to bring together regional center staff, service providers, individuals served, advocates, and family members.

## Community and Legislative Educator Report May 2025

### LEGISLATIVE BILL TRACKER

**AB 276 (Bennett) Background Checks** - This bill would allow a licensee of a community care facility to temporarily approve an individual to care for children before completing an out-of-state child abuse and neglect registry check, provided specific conditions are met. It would also require immediate removal of the individual and notification to the department within 3 business days if disqualifying information is received.

**Status:** Introduced on **January 21, 2025** | In committee: Set, first hearing. Referred to suspense file on **April 23, 2025**.

**AB 277 (Alanis) Behavioral Health Centers, Facilities, and Programs: Background Checks** - Under existing law, businesses that serve minors must provide written notice to parents or guardians about their employee background check policies. The Department of Justice (DOJ) is authorized to maintain and disclose state summary criminal history information to specified entities, such as employers or human resource agencies. Unauthorized disclosure is considered a crime. This bill would expand these protections by requiring that any individual who provides behavioral health treatment at a behavioral health center, facility, or program must undergo a criminal background check.

**Status:** Introduced on **January 21, 2025** | In committee: Set, first hearing. Referred to suspense file on **April 23, 2025**.

**AB 308 (Ramos) Mobile Crisis Teams or Units: Procedures** – This bill would authorize county behavioral health directors to develop procedures for mobile crisis teams or units to handle emergencies involving individuals with intellectual/developmental disabilities or behavioral health conditions.

**Status:** Introduced on **January 23, 2025** | In senate, read for the first time on **May 8, 2025**.

**AB 315 (Bonta) Medi-Cal: Home and Community-Based Alternatives Waiver** – This bill would recast provisions related to the Home and Community-Based Alternatives (HCBA) Waiver to require the enrollment of all eligible applicants and direct the Department of Health Care Services to seek amendments to ensure adequate waiver capacity by March 1, 2026.

**Status:** Introduced on **January 23, 2025** | In committee: Set, first hearing. Referred to the Appropriations Committee on **April 9, 2025**.

**AB 346 (Nguyen) In-Home Supportive Services: Licensed Health Care Professional Certification** – This bill would broaden the definition of a "licensed healthcare professional" authorized to certify an individual for IHSS eligibility, allowing a wider range of medical professionals to provide necessary documentation.

**Status:** Introduced on **January 29, 2025**; In committee: Set, first hearing. Referred to suspense



file on **May 7, 2025**.

**AB 636 (Ortega) Medi-Cal: Diapers** – This bill would establish diapers as a covered Medi-Cal benefit for children over 3 years of age with a diagnosed condition causing incontinence, and for individuals under 21 if necessary to address a medical condition. The bill requires federal approval, funding from the Legislature, and updates to the Medi-Cal provider manual to implement the provisions.

**Status:** Introduced on **February 13, 2025** | In committee: Set, first hearing. Referred to suspense file on **April 23, 2025**.

**AB 804 (Wicks) Medi-Cal: Housing Support Services** – This bill would make housing support services a covered Medi-Cal benefit for individuals who are homeless or at risk of homelessness, contingent upon legislative appropriation. It removes the requirement for a state-conducted network adequacy analysis and directs the Department of Health Care Services to seek federal approval for this benefit.

**Status:** Introduced on **February 18, 2025** | In committee: Set, first hearing. Referred to suspense file on **May 7, 2025**.

**AB 951 (Ta) Health Care Coverage: Behavioral Diagnoses** – This bill would prohibit health plans from requiring individuals previously diagnosed with autism or a related disorder to undergo rediagnosis in order to maintain behavioral health treatment coverage. Treatment plans must be available upon insurer request.

**Status:** Introduced on **February 20, 2025** | Referred to the Health Committee on **May 7, 2025**.

**AB 1076 (Addis) Qualified ABLE Program: CalABLE Accounts: Funding** – This bill would authorize the California ABLE Act Board to additionally accept grants, gifts, appropriations, and other moneys from a philanthropic entity, and would specify that the program can receive legislative appropriations. It also authorizes the board to use funds to promote ABLE account enrollment and usage, including financial incentives for eligible individuals. CalABLE provides tax-advantaged savings accounts for individuals with disabilities without affecting their eligibility for public benefits—this bill would strengthen the program's ability to expand outreach, increase participation, and secure diverse funding to support long-term financial stability for our population.

**AB 1099 (Bryan) Developmental Services: Initial Intake: Assessment** – This bill would require regional centers to refer foster children for additional assessment within 15 days if eligibility for services has not yet been determined. It prohibits denying an assessment solely due to missing documentation and requires the Department of Developmental Services to report annual intake data, including the number involving foster children.

**AB 1172 (Nguyen) Adult Day Programs: Administration of Inhalable Emergency**

**Antiseizure Medications** – This bill would authorize trained staff at adult day programs to administer inhalable emergency antiseizure medication to participants with epilepsy or seizure disorders during a seizure emergency, provided they have received appropriate training and the participant has a prescription for the medication. This measure aims to enhance the safety and well-being of individuals with seizure disorders in adult day programs by ensuring timely intervention during seizure emergencies.

**Status:** Introduced on **February 21, 2025** | In committee: Set, first hearing. Referred to suspense file on **April 30, 2025**.

**AB 1335 (Gonzalez) Habilitation Services** – This bill would remove the requirement for work activity and support employment programs to comply with CARF accreditation standards. Instead, regional centers would evaluate service providers using department-adopted service standards.

**Status:** Introduced on **February 21, 2025** | From committee: Without further action pursuant to Joint Rule 62(a) on **May 1, 2025**.

**SB 422 (Grayson) California Workforce Development Board: developmental services** –

This bill would require the board, on or before January 1, 2027, to review existing recommendations and to research and provide a report to the Governor and the Legislature including recommendations on the most compelling strategies for addressing the workforce shortage in California's developmental services system, as specified. The bill would require the State Department of Developmental Services to provide staff support and expertise to the board for this purpose.

**GOVERNOR NEWSOM'S MAY REVISION 2025-26**

**Governor Newsom's 2025-26 May Revision** outlines significant General Fund reductions across Health and Human Services in response to the state's projected **\$27.6 billion deficit**. Several proposed actions directly affect individuals with developmental disabilities, Regional Centers, and the vendor community.

**Department of Developmental Services (DDS):**

- **\$221.7M ongoing cut (starting 2026-27):** Providers must comply with EVV, audits, and HCBS rules to qualify for quality incentive payments.
- **\$75M reduction in 2025-26:** Ends rate reform hold harmless four months early (February 2026).

- **Self-Determination Program:** Reduced by \$22.5M in 2025-26, and \$45.5M ongoing due to cost guardrails.
- **Eliminates DSP Workforce Training Program:** \$36.8M ongoing cut to the unimplemented Direct Support Professional training initiative.
- **Elimination of targeted supports:**
  - \$5.6M for implicit bias training refresh
  - \$3M for health & safety waiver assistance
- **Porterville Developmental Center:** \$10M ongoing reduction starting 2026-27 based on historical savings.
- **Cost Recovery and Reimbursement:** DDS will pursue increased reimbursements and service cost recovery (savings TBD).

#### **DDS Investments:**

- **\$13.3M in FY2025-26** for the **Life Outcomes Improvement System (LOIS)** to support continued planning efforts, including 17 limited-term DDS positions and regional center resources.
- **\$1.9M in FY2025-26** for **federal HCBS Access Rule compliance**, including 9 limited-term positions to manage increased regulatory workload.
- **\$1.4M in FY2025-26**, increasing to **\$2M ongoing**, for **health and safety investigations and due process caseloads**, supporting 9 new permanent positions.
- **\$680K in FY2025-26** for **clinical monitoring of specialized community homes**, with 4 new permanent positions.
- **\$1.3M in FY2025-26** to support **cost recovery and reimbursement efforts**, including 5 permanent positions and external consultant support.

#### **Department of Health Care Services (Medi-Cal):**

- **Freezes Medi-Cal enrollment** for adults (19+) with unsatisfactory immigration status (UIS) – **\$86.5M in 2025-26**, growing to **\$3.3B by 2028-29**
- **Eliminates long-term care and dental** for UIS adults – **Over \$600M in annual savings by 2028**
- **\$100 monthly premiums** for certain Medi-Cal adults starting 2027 – **\$2.1B by 2028-29**
- **Reinstates asset test** (\$2,000 individual / \$3,000 couple) – **\$791M ongoing**
- **Cuts to FQHCs, Prop 56 payments, and weight-loss drug coverage**
- **Prescription cost controls via rebates, step therapy, and prior authorization** are projected to save **\$200 million** in 2025-26 and **\$400 million annually thereafter**

#### **In-Home Supportive Services:**

- **Caps provider Overtime/travel to 50 hours/week** – **\$707.5M ongoing savings**
- **Aligns IHSS Residual Program** with Medi-Cal timing – **effectively eliminates the program**
- **Eliminates IHSS eligibility for adults 19+ with UIS** – **\$158.8M ongoing**
- **Shifts reassessment penalties to counties** – **\$81M savings**

- Conforms IHSS to Medi-Cal asset test – **\$25.5M in 2025-26**

### Next Steps:

The Legislature will finalize the budget by **June 15, 2025**. NLACRC will continue to monitor outcomes and advocate to protect access and quality of services for individuals with developmental disabilities and our provider community.

### CONGRESSIONAL BUDGET OFFICE MEMO (MEDICAID)

On May 11th, the **House Energy and Commerce Committee** released draft budget reconciliation legislation that includes major Medicaid restructuring proposals under **Subtitle D**. The **Congressional Budget Office (CBO)** has reviewed these proposals and estimates **\$715 billion in federal Medicaid and ACA-related cuts** over the next ten years (2025–2034). These provisions could significantly affect California’s Medi-Cal program and, by extension, services provided to individuals with developmental disabilities.

Key Proposals Identified by the CBO (Subtitle D – Medicaid & ACA):

- **Reduction in FMAP for Expansion States (Including California):**  
Proposes a decrease in the **Federal Medical Assistance Percentage (FMAP)** for states that expanded Medicaid under the ACA, which includes California.  
→ *Potential Result: Less federal funding to support Medi-Cal services.*
- **Moratorium on New or Increased Provider Taxes:**  
Would block states from implementing new or higher **provider taxes**, which are often used to draw down federal matching funds.  
→ *Could limit California’s ability to sustain or expand Medi-Cal funding.*
- **Medicaid Work or Volunteer Requirements:**  
States would be required to implement **work or community engagement requirements** for certain Medicaid beneficiaries.  
→ *May impose eligibility barriers on individuals with disabilities and family caregivers.*
- **Changes to Cost-Sharing for Medicaid Expansion Population:**  
Proposals would **increase cost-sharing** obligations for certain low-income individuals enrolled through the expansion population.  
→ *Could lead to decreased access to care for vulnerable communities.*
- **Moratorium on Staffing Standards in Long-Term Care Facilities (Medicare & Medicaid):**  
Suspends planned federal rules aimed at strengthening staffing levels in **nursing homes and long-term care settings**.  
→ *May impact quality of care in facilities serving people with developmental disabilities.*

## **EMERGENCY HOUSING VOUCHER PROGRAM ENDING**

The Emergency Housing Voucher (EHV) Program, a \$5 billion federal initiative created to prevent homelessness, is nearly out of funding. According to HUD, there is no plan to renew or extend the program, putting 60,000 renters nationwide, including 15,000+ in California, at risk of losing housing.

The EHV program—modeled after Section 8—was designed for individuals with urgent housing needs, including:

- Individuals facing housing instability
- Those escaping unsafe or abusive living situations
- People transitioning from temporary or institutional care environments

Without federal renewal, the program's expiration may increase housing instability for vulnerable populations, including individuals with developmental disabilities who rely on housing assistance to maintain community living.
