There being a quorum present, and adequate and proper notice of the meeting having been given, the meeting was called to order at 9:31 a.m. Alex Kopilevich presided as Chair.

#### 6. ACTION ITEMS

#### 6.1 Review and Approve Draft Critical Calendar for Next Fiscal Year 2025-2026

The draft critical calendar for the next fiscal year 2025-2026 was reviewed. Sharon Weinberg asked for elaboration on the new process of conducting the interviews and reviewing the applicants for the new VAC members.

Alex Kopilevich explained that the VAC would now be reviewing the applications and conducting the interviews before presenting the slate of candidates to the Board of Trustees. This process was previously done by the Nominating Committee.

#### 7. COMMITTEE BUSINESS

#### 7.1 Discuss Committee Goals for Next Fiscal Year

Alex Kopilevich presented the committee goals for next fiscal year. The VAC members for each of the committee workgroups were asked to email the committee goals for next fiscal year to Board Support by May 30<sup>th</sup>.

#### 7.2 Workgroups and Committee Report Outs for Next Fiscal Year

Alex Kopilevich presented the workgroups and committee report outs for next fiscal year. It was noted that this list would be the same list as the agenda item above. The current members on the different committees were asked if they are interested in continuing in their role for the next fiscal year. Jodie Agnew-Navarro is interested in continuing in her role with Early Start Services. Paul Borda and Cal Enriquez are both interested in continuing in their role with School Age Services. Octavia Watkins is interested in continuing her role with Adult Services.

#### 7.3 Update on NLACRC's Local Delegation Team

Belinda Abatesi presented an update on the local delegation teams. Paul Borda, Octavia Watkins, and Jodie Agnew-Navarro were thanked for joining the visits with Assemblyman Lackey and Assemblywoman Schiavo. NLACRC's first two podcast episodes feature conversations between Executive Director Angela Pao-Johnson and the two legislators. Angela Pao-Johnson asked Belinda Abatesi to share on upcoming legislative visits that would be relevant to the vendor community. Belinda Abatesi will send out emails for the upcoming legislative events with the LA County Supervisors.

#### **Octavia Watkins**

Shared on the experience with Assemblyman Lackey and shared appreciation with the leadership shown by Angela Pao-Johnson to create a safe space for everyone present to share.

Increasing client and consumer engagement in legislative events to share anecdotes and personal experiences with the legislators was noted.

ACTION: Belinda will send out emails with information on the upcoming legislator visits.

#### 7.4 <u>Update on Service Provider Vendor Training/Mentorship Program Updates</u>

Alex Kopilevich presented an update on service provider vendor training and mentorship programs. The group has met and discussed the various topics and will be meeting with community services to finalize everything to move forward in the next fiscal year.

#### 7.5 Self-Determination Update

Silvia Renteria-Haro presented the self-determination update. It was noted that DDS published a new guidance for FMS Agencies effective April 22 with new requirements for those who want to be vendored.

#### 7.6 Update on VAC Open Positions

Alex Kopilevich presented an update on the open Vendor Advisory Committee positions. Four applicants were selected to go before the Board of Trustees for a vote at the June meeting.

#### 8. REPORT OUTS

#### 8.1 <u>Deputy Director Officer's Deport</u>

Evelyn McOmie presented the Deputy Director Officer's report.

An update on a project that has been referenced as the escalation process for vendors, which will now be called communication strategies for service providers. A presentation was shared outlining this communication strategies. The escalation procedures will be available in NLACRC's vendor portal. There was a reminder to include their vendor number to improve communication. Evelyn McOmie emphasized that this will be further developed and is anticipating to roll out the new communication strategies for service providers in July at the beginning of the new fiscal year. Throughout the month of July, NLACRC anticipates promoting this and deploying it within the departments that work with vendors.

There was an inquiry about the urgency category and if that will be identified by the vendors in the email or assigned by the regional center.

Evelyn McOmie replied that this will be identified by the service provider in the subject line and will be flagged.

Jen Pippard confirmed with Evelyn McOmie that the document that was shared is just a draft.

#### 8.2 Chief Financial Officer's Report

Vini Montague presented the Chief Financial Officer's report. The Vendor Portal was highlighted noting that an email was sent by Community Services to all vendors to register on the vendor portal. Notifications will be sent notifications once NLACRC is ready to stop sending out hard copies. All vendors that have not registered were asked to sign up. Also, vendors that need anything on the accounts payables side that needs to be escalated to a supervisor should reach out Justice Agonov NLACRC's controller.

#### 8.3 Community Services Director's Report

Arshalous Garlanian presented the Community Services Director's Report, specifically highlighting rate reform for service code 605, 805, 116, and 117 providers. It was asked that

Angela Pao-Johnson noted the Medicaid rally that was previously attended by staff, vendors, individuals served, members of the community, and more in Bakersfield on April 24<sup>th</sup>. Also, NLACRC's podcast series is named Voices in Action has launched with episodes with Assemblyman Lackey and Assemblywoman Schiavo on NLACRC's website.

#### 8.5 Executive Director's Report

Angela Pao-Johnson presented the Executive Director's report, highlighting important points. On April 24<sup>th</sup>, members of the NLACRC community participated in a rally in Bakersfield to show a strong collective commitment to advocacy and community solidarity.

## **Legislative Bills**

AB 276 (Bennett) Background Checks - This bill would allow a licensee of a community care facility to temporarily approve an individual to care for children before completing an out-of-state child abuse and neglect registry check, provided specific conditions are met. It would also require immediate removal of the individual and notification to the department within 3 business days if disqualifying information is received.

AB 277 (Alanis) Behavioral Health Centers, Facilities, and Programs: Background Checks - Under existing law, businesses that serve minors must provide written notice to parents or guardians about their employee background check policies. The Department of Justice (DOJ) is authorized to maintain and disclose state summary criminal history information to specified entities, such as employers or human resource agencies. Unauthorized disclosure is considered a crime. This bill would expand these protections by requiring that any individual who provides behavioral health treatment at a behavioral health center, facility, or program must undergo a criminal background check.

AB 308 (Ramos) Mobile Crisis Teams or Units: Procedures –This bill would authorize county behavioral health directors to develop procedures for mobile crisis teams or units to handle emergencies involving individuals with intellectual/developmental disabilities or behavioral health conditions.

AB 315 (Bonta) Medi-Cal: Home and Community-Based Alternatives Waiver – This bill would recast provisions related to the Home and Community-Based Alternatives (HCBA) Waiver to require the enrollment of all eligible applicants and direct the Department of Health Care Services to seek amendments to ensure adequate waiver capacity by March 1, 2026.

AB 346 (Nguyen) In-Home Supportive Services: Licensed Health Care Professional Certification – This bill would broaden the definition of a "licensed healthcare professional" authorized to certify an individual for IHSS eligibility, allowing a wider range of medical professionals to provide necessary documentation.

AB 636 (Ortega) Medi-Cal: Diapers – This bill would establish diapers as a covered Medi-Cal benefit for children over 3 years of age with a diagnosed condition causing incontinence, and for individuals under 21 if necessary to address a medical condition. The bill requires federal approval, funding from the Legislature, and updates to the Medi-Cal provider manual to implement the provisions.

AB 804 (Wicks) Medi-Cal: Housing Support Services – This bill would make housing support services a covered Medi-Cal benefit for individuals who are homeless or at risk of homelessness, contingent upon legislative appropriation. It removes the requirement for a state-conducted network adequacy analysis and directs the Department of Health Care Services to seek federal approval for this benefit.

AB 951 (Ta) Health Care Coverage: Behavioral Diagnoses – This bill would prohibit health plans from requiring individuals previously diagnosed with autism or a related disorder to undergo rediagnosis in order to maintain behavioral health treatment coverage. AB 1076 (Addis) Qualified ABLE Program: CalABLE Accounts: Funding – This bill would authorize the California ABLE Act Board to additionally accept grants, gifts, appropriations, and other moneys from a philanthropic entity, and would specify that the program can receive legislative appropriations. It also authorizes the board to use funds to promote ABLE account enrollment and usage, including financial incentives for eligible individuals. CalABLE provides tax-advantaged savings accounts for individuals with disabilities without affecting their eligibility for public benefits—this bill would strengthen the program's ability to expand outreach, increase participation, and secure diverse funding to support long-term financial stability for our population. <a href="Status: Introduced on February 20">Status: Introduced on February 20</a>, 2025 | In Senate. AB 1099 (Bryan) Developmental Services: Initial Intake: Assessment – This bill would require regional centers to refer foster children for additional assessment within 15 days if eligibility for services has not yet been determined. It prohibits denying an assessment solely due to missing documentation and requires the Department of Developmental Services to report annual intake data, including the number involving foster children.

AB 1172 (Nguyen) Adult Day Programs: Administration of Inhalable Emergency
Antiseizure Medications – This bill would authorize trained staff at adult day programs to
administer inhalable emergency antiseizure medication to participants with epilepsy or seizure
disorders during a seizure emergency, provided they have received appropriate training and the
participant has a prescription for the medication. This measure aims to enhance the safety and
well-being of individuals with seizure disorders in adult day programs by ensuring timely
intervention during seizure emergencies.

AB 1335 (Gonzalez) Habilitation Services – This bill would remove the requirement for work activity and support employment programs to comply with CARF accreditation standards. Instead, regional centers would evaluate service providers using department-adopted service standards.

The bill would require the State Department of Developmental Services to provide staff support and expertise to the board for this purpose.

## Federal Update: House Passes Budget Bill Cutting Medicaid & SNAP

On May 22, 2025, the U.S. House of Representatives passed a budget reconciliation bill that proposes historic cuts to **Medicaid and the Supplemental Nutrition Assistance Program** (**SNAP**)—critical programs supporting millions of people with disabilities.

### **Key Provisions in the House Bill:**

- \$715 billion cut to Medicaid, threatening access to Medi-Cal, regional center services, IHSS, early intervention, and more.
- 13.7 million people are projected to lose health insurance due to combined cuts and policy changes.

- \$300 billion cut to SNAP (CalFresh), the largest in program history.
- Increased administrative barriers including biannual Medicaid eligibility renewals.
- New strict work requirements aimed at reducing enrollment.

## **Governor Newsom's May Revision 2025-26**

In response to a projected **\$27.6 billion deficit**, Governor Newsom's revised budget proposes major cuts across Health and Human Services, directly impacting the developmental disability community.

#### **Department of Developmental Services (DDS):**

- **\$221.7M ongoing cut (starting 2026-27):** Providers must comply with EVV, audits, and HCBS rules to qualify for quality incentive payments.
- \$75M reduction in 2025-26: Ends rate reform "hold harmless" four months early (February 2026).
- Self-Determination Program reductions: \$22.5M in 2025-26 and \$45.5M ongoing
- Eliminates DSP Workforce Training Program: \$36.8M ongoing cut
- Cuts to targeted supports: Implicit bias training (\$5.6M), health & safety waiver assistance (\$3M)
- **Porterville Developmental Center:** \$10M ongoing reduction starting 2026-27 based on historical savings.
- Cost Recovery and Reimbursement: DDS will pursue increased reimbursements and service cost recovery (savings TBD).

#### **DDS Investments:**

- \$13.3M for LOIS planning
- \$1.9M for HCBS Access Rule compliance
- \$1.4M—\$2M for due process support
- \$680K for clinical monitoring
- \$1.3M for cost recovery and reimbursement efforts

#### **Department of Health Care Services (Medi-Cal):**

- Medi-Cal freeze for adults with unsatisfactory immigration status (UIS)
- Cuts to long-term care and dental for UIS adults
- \$100 monthly Medi-Cal premiums (starting 2027)
- Reinstates asset test (\$2,000 individual / \$3,000 couple)
- Prescription cost controls and cuts to FQHCs/Prop 56

- Caps overtime/travel to 50 hours/week
- Eliminates IHSS for UIS adults

## Governor's Reorganization Plan: New Housing & Business Agencies

Governor Newsom's 2025-26 budget includes a proposal to reorganize the **Business**, **Consumer Services**, **and Housing Agency (BCSH)** into two new cabinet-level agencies:

- California Housing and Homelessness Agency (CHHA):
   Will oversee housing, homelessness prevention, and civil rights programs.
- Business and Consumer Services Agency (BCSA):
   Will focus on consumer protection and business regulation (e.g., licensing via the Department of Consumer Affairs).

The Little Hoover Commission, California's independent oversight body, approved the plan on June 2, 2025. The Legislature has until July 4 to reject the proposal. If not, it automatically takes effect July 5.

#### CalABLE & Medi-Cal Asset Limits – What You Should Know

On May 30, 2025, **State Treasurer Fiona Ma** released a statement opposing the reinstatement of Medi-Cal's outdated **\$2,000 asset limit**. This cap discourages saving and threatens the independence of individuals with disabilities.

**CalABLE accounts** offer a solution—allowing individuals to save up to \$100,000 without affecting benefits like Medi-Cal and SSI. As of now, over 14,000 Californians have saved nearly \$200 million through CalABLE.

## North Los Angeles County Regional Center Director's Report

June 2025

#### 1. NLACRC Spotlight:

- **A. Parent University** is a family-focused training initiative developed by the Diversity, Equity, Inclusion, and Belonging (DEIB) team. The curriculum is designed to help families better understand how the regional center system works and what they can expect.
  - I. The training is being delivered in a microlearning format using animated infographics to ensure accessibility and ease of use.
  - II. A total of 19 videos are planned, covering key topics relevant to families served by the regional center.
  - III. The videos will be made available on the NLACRC website and shared via social media platforms. The full series will be completed by early June.
- **B.** Psychological Assessment Expansion: NLACRC has made significant progress in recruiting and contracting additional psychologists to support intake and Early Start assessments.
  - I. As a result, the Regional Center can now offer more psychological testing appointments allowing families to be evaluated more quickly.
  - II. In 2024, NLACRC averaged 362 psychological testing appointments per month.
  - III. In 2025, the average has increased to 599 psychological testing appointments per month, reflecting a major improvement in access and timeliness.
- **C. Equity & Cultural Humility Training:** In April, NLACRC's Diversity, Equity, Inclusion, and Belonging (DEIB) team facilitated their first Equity & Cultural Humility Training for newly hired staff.
  - I. This marks an important step in embedding equity-focused practices into the onboarding experience at NLACRC.

#### 2. <u>Department of Developmental Services (DDS) Updates:</u>

- **A.** The DDS' May Revision for Fiscal Year (FY) 2025-26 includes \$18.7 billion in total funding, with \$12.2 billion from the General Fund.
  - I. This reflects a \$3.0 billion increase compared to FY 2024-25.
  - II. Caseloads are projected to increase from 452,188 in FY 2024-25 to 491,080 in FY 2025-26.
    - a. Regional Center operations funding for FY 2025-26 is set at \$1.65 billion, with reductions reflecting the updated caseload.
    - b. There are no reductions to operational funding for FY 2024-25, despite caseload projections being lower than those projected in January.

- III. The Life Outcomes Improvement System (LOIS) will receive \$13.3 million to continue planning and implementation.
- IV. The Rate Reform "Hold Harmless" provision for service providers will end earlier, in February 2026, resulting in \$75 million in General Fund savings for FY 2025-26.
- V. Funding for Workforce Training & Development (DSP University) is eliminated, including:
  - a. \$17.6 million cut in both FY 2025-26 and FY 2026-27.
  - b. \$36.8 million cut on an ongoing basis starting FY 2027-28.
- VI. Funding for the Self-Determination Program is reduced by \$22.5 million in FY 2025-26, with ongoing reductions of \$45.5 million annually.
  - a. Despite this, the program is still expected to grow by nearly \$240 million year-over-year, with small increases in per-person expenditures.
- VII. Purchase of Services (POS) budget adjustments reflect updated utilization patterns:
  - a. Transportation services are reduced by \$192 million.
  - b. Community Care Facilities are reduced by \$83 million.
  - c. In-Home Respite services are reduced by \$23 million.
- VIII. Expected federal reimbursements in FY 2025-26 are lowered by \$103 million from initial estimates, primarily from HCBS Waiver adjustments, but are still anticipated to rise significantly from FY 2024-25.

#### 3. <u>Community Services QA Report</u>

- **A.** Compliance Activities
  - I. QA conducted 112 residential visits
    - a. 59 Unannounced In-Person Visits
      - i. 29 CCFs, 30 ICFs, 0 FHAs, 0 FFA (10 AV, 49 SFV/SC)
    - b. 37 Annual Reviews CCF and Day Program (10 AV, 27 SFV/SC)
    - c. 16 Other: 0 Virtual, 16 In-Person (DDS Reviews, New Provider Orientation, QA/RD Walkthrough, 7 Day visit, SIR Follow/Complaint/CAP Follow-up, Attempted Unannounced Visits – provider was not home)
    - d. 3 Corrective Action Plans developed with residential providers
    - e. 0 Plan of Improvement with non-residential provider

#### 4. <u>Federal Budget Developments</u>:

- **A.** On April 10, 2025, Congress approved a budget resolution that includes:
  - I. \$5.3 trillion in tax cuts
  - II. \$5 trillion increases in the debt ceiling
  - III. \$1.5 to \$2 trillion in federal spending cuts
  - IV. \$521 billion increase in select federal spending
- **B.** These provisions are being advanced through the "One Big Beautiful Act," which moved out of the House of Representatives on May 22, 2025, by a narrow 215-214 vote.
  - I. The bill is now headed to the Senate for consideration.

- **C.** Updated Spending Cuts Proposal by the House Energy and Commerce Committee:
  - I. \$715 billion in cuts to Medicaid and health programs
  - II. \$197 billion in cuts to other federal programs
  - III. The proposed Medicaid changes represent the largest reduction in the program's history.
    - a. Cuts are part of a broader package that includes:
      - i. Work requirements for Medicaid (80 hours/month)
      - ii. Defense and boarder security increases totaling over \$220 billion
      - iii. Major tax changes, including expansion of the 2017 Tax Cuts and Jobs Act

#### D. Impact on Californians

- I. The bill imposes new monthly work reporting requirements for Medicaid, with limited exceptions for people who are medically fragile or have disabilities.
- II. In California, an estimated 43% of residents over 17 million people could be severely impacted, especially low-income families, seniors, and people with disabilities, who rely on Medi-Cal.
- III. Coverage may be paused or lost frequently due to the state's obligation to verify work status monthly.
