## Board Resolution Change in Authorized Signers and Representatives Citibank N.A.

The following resolution was adopted at a meeting of the Board of Trustees of the North Los Angeles County Regional Center (“NLACRC”) held on the 10<sup>th</sup> day of June 2026, in accordance with the applicable laws and bylaws of the organization.

**WHEREAS**, the Board of Trustees previously adopted a resolution on November 30, 2022, authorizing the Executive Director of NLACRC, Chief Financial Officer of NLACRC and Chief Human Resources Officer of NLACRC, each individually, to open, operate, and provide instructions with respect to a bank account with Citibank N.A. (“Citibank”) for use in connection with NLACRC’s PPO Dental Plan administered by CIGNA Corporation (“CIGNA”), such account being referred to herein as the “Bank Account”;

**NOW, THEREFORE, BE IT RESOLVED**, that the following is removed as authorized signer and representative with respect to the Bank Account:

**RESOLVED**, that the following individual employed by NLACRC is hereby added as authorized signer and authorized representative with respect to the Bank Account:

Deputy Director of NLACRC

**RESOLVED**, that the following individuals employed by the Department of Developmental Services (“DDS”) are hereby added as authorized signers and authorized representatives with respect to the Bank Account:

Deputy Director, Administration Division of DDS  
Chief Deputy Director of Program Services of DDS

**RESOLVED**, that the Deputy Director of NLACRC; Deputy Director, Administration Division of DDS; and Chief Deputy Director of Program Services of DDS shall be vested with all rights, powers, and authority granted to authorized representatives with respect to the Bank Account under the original Board Resolution.

**RESOLVED**, that all other provisions of the original Board Resolution, including the authority granted to CIGNA with respect to the Bank Account, shall remain unchanged and in full force and effect.
